**Collaborate:** Work with peers, faculty, and staff to foster an inclusive community.

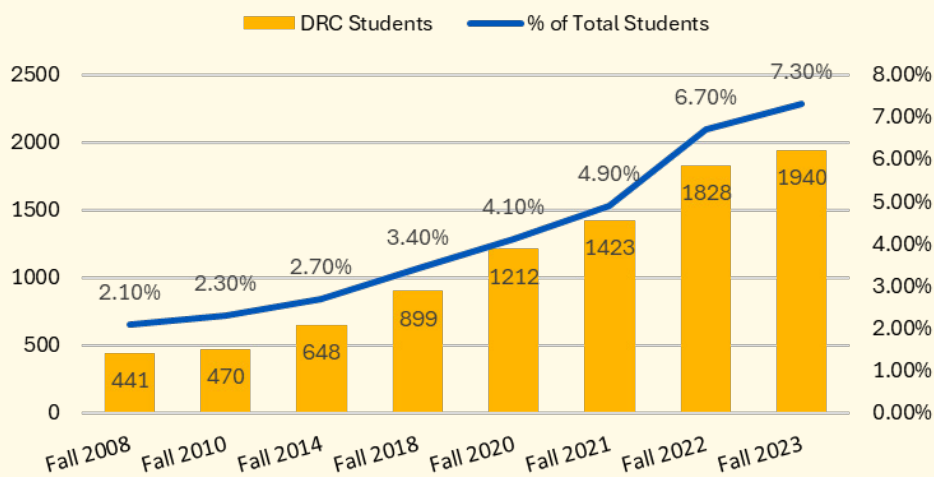
Being able to utilize technology not only allowed me to function nearly at the same capacity as my peers, it gave me confidence as well.
