Introduction

The California State Polytechnic University, Pomona Emergency Management Program

In pursuant to California State University Executive Order 1056; the California State Polytechnic University, Pomona (CPP) Emergency Management Program will provide the coordination and management of all

stages of emergencies and disasters on a campus-wide basis. This is accomplished through the utilization of the phases of emergency management; prevention, mitigation, preparedness, response, and recovery. These phases are used to accomplish the tasks associated mission and to ensure CPP's resilience to emergencies or a disaster through an all-hazards, whole-community approach. The CPP Emergency Management Program will work and coordinate with CPP emergency responders, staff, faculty, facilities, the student population, fire departments, local, county, state, and federal agencies, and the private sector to coordinate the needed resources to respond to and recover from an emergency or disaster affecting the CPP campus or its population.

The CPP Emergency Management Program maintains many plans and procedures, including an All-Hazard Emergency Operations Plan (EOP).

Only through well-prepared CPP first responders, executives, staff, faculty, the student population, and other emergency response partners will we be prepared when an emergency or a disaster strikes.

Preface to the CPP Multi-Year Training & Exercise Plan

The CPP Multi-Year Training & Exercise Plan (TEP) is a roadmap for CPP to accomplish the strategies and objectives outlined in the Emergency Management Program Strategic Framework. The Emergency Management Program has laid out a coordinated strategy that combines enhanced planning, innovative training, and realistic exercises to strengthen the University's emergency preparedness and response capabilities. Training and exercises play a crucial role in providing the University with a means of attaining, practicing, validating, and improving its emergency response and recovery capabilities.

Purpose of the Multi-Year Training & Exercise Plan

The purpose of the Multi-Year TEP is to provide a follow-on companion document to the CPP Emergency Management Program's Strategic Framework that identifies the top priorities for improving the preparedness and response capabilities of the University and define and guide the cycle of training and exercise activities that will provide the most benefit in the development, refinement, and maintenance of those capabilities. Included in this document are training and exercise tentative schedules providing a graphic illustration of the proposed activities for the years 2021-2022 through 2025-2026. This is a living document that will be updated and refined annually.


CPP Multi-Year Training & Exercise Plan Overview

The CPP Emergency Management Training & Exercise Plan uses a building-block approach to plan training courses and exercises based on the county's priorities. The building-block approach outlines a training and exercise regimen that maximizes mutual reinforcement, allows for sensible preparation (e.g., equipment purchase or training courses), and ensures progression in exercise complexity. These projected training and exercise activities are scheduled from January 2021 to June 30, 2026.

The Multi-Year Training & Exercise Plan is divided into multiple categories: Monthly Drills & Tests, Monthly Training Conducted & Offered, Periodically Conducted Drills & Tests, Periodically Conducted Training Classes & Community Education, Exercise (Tabletop, Functional & Full-scale), Special Training and Classes. The Plan will also track and document actual incidents occurring and After-Action Reports (AAR), Exercise Summary Reports (ESRs), and Incident Summary (ISRs) that have been developed.

In pursuant to California State University Executive Order 1056; Full-scale exercising should be done every five years, however, activation of the EOC in response to an actual emergency or disaster will meet required exercise requirement. provided such emergency is documented and discussed with the campus emergency management team.

In pursuant to California State University Executive Order 1056; the activation of the EOC in response to an actual emergency or disaster will count as training to meeting the requirements, provided such emergency is documented and discussed with the campus emergency management team.





CPP Multi-Year Training & Exercise Planning Priorities

The CPP Emergency Management Program's Strategic Framework provides strategies and objectives to accomplish those strategies. These objectives are the foundation for the development of the Multi-Year TEP. The Preparedness Strategies and Objectives for training and exercising.

Strategy: The CPP Emergency Management Program will support and continue to train CPP first responders, Evacuation Coordinators (EC), the CPP Rapid Response Team (RRT) including the CPP executive-level effectively respond to an emergency or disaster.


- Objective: Develop and conduct training for the executive level of the CPP RRT staff.
- **Objective:** Encourage the completion of National Incident Management System (NIMS) Incident Command courses by the RRT and EC.
- Objective: Increase training and education for CPP staff and faculty in disaster preparedness and their roles in the event of an emergency or disaster as CPP employees including their role as Disaster Service Workers. This includes off site satellite locations where CPP staff, students, and faculty are physically located.
- **Objective:** Conduct hazardous materials refresher training for CPP Police Department personnel.
- Objective: Conduct annual training for all ECs.

Strategy: The CPP Emergency Management Program will support and continue to conduct emergency response exercises for the CPP following the Homeland Security Exercise and Evaluation Program (HSEEP), all exercises will be coordinated to ensure Clery Act required exercise compliance.


- **Objective:** Maintain and update the multi-year training and exercise plan for the University every five years.


After Action Report (AAR) Evaluation & Analysis



Attachment 1 CPP University President & Cabinet Emergency Training Plan

Purpose

A disaster or emergency may have implications requiring executive decision-making, the potential for long-term implications on the viability and reputation of the campus, or may require significant changes in existing policies.

The University President and the Executive Policy Group have the ultimate authority for all University policies.

The University President and the University Cabinet is the executive-level oversight and strategic decision-making body for CPP during a crisis and performs the role of the Executive/Policy Group in the Incident Management Structure and is an integral part of the Emergency Operations Center in an emergency or disaster.

The Executive/Policy Group has the authority to make strategic, financial, operational, and policy decisions in response to the issue or event. If the implications of a crisis require executive decision-making, have potential long-term implications on the viability and reputation of the campus, or require significant changes in existing policies, the Executive/Policy Group will be involved in the day-to-day management of the crisis. The Executive/Policy Group makes proactive policy and strategic decisions to mitigate expected impacts and is responsible for ensuring that CPP and critical stakeholders are properly appraised and consulted.

Emergency preparedness training and participation in exercises are essential to understand the roles and responsibilities of the Executive/ Policy Group during the activation of the Emergency Operations Center for an emergency. The required training for the University President and the University Cabinet are laid out in the University President & Cabinet Emergency Training Plan, a part of the CPP Campus Emergency Preparedness Multi-Year Training and Exercise Plan.

Required Courses

CPP Emergency Management, EOC Operations, NIMS/SEMS, and ICS Fundamentals Training Course – Policy Group

Purpose

Emergency preparedness training and participation in exercises are essential to understand the roles and responsibilities of the Rapid Response Team during the activation of the Emergency Operations Center for an emergency. The required training for the members of the CPP EOC Team and Rapid Response Team are laid out in the Rapid Response Team Training Plan, a part of the CPP Campus Emergency Preparedness Multi-Year Training and Exercise Plan.

Required Courses

CPP Emergency Management, EOC Operations, NIMS/SEMS, and ICS Fundamentals Training Course – Policy Group

The purpose of this course is to provide the necessary Emergency Management, EOC Operations, NIMS/SEMS, and ICS fundamentals encompassing IS-100, IS-200, IS-700, IS-800, IS-191, and IS-2200 courses in an adapted course best suited to meet the needs of the University. This course will equip staff with the knowledge necessary to make empowered decisions in the EOC.

CPP Rapid Response Team - Position-Specific Training

Course Overview

Position-Specific Training is to provide the additional training that may be needed by personnel responsible for managing incidents. This training is designed to provide all-hazards competencies for command, general staff, and selected unit leader positions within a Rapid Response Team (RRT). The training is focused on specific position responsibilities, leading assigned personnel, communicating effectively, and ensuring the completion of assigned tasks to meet identified objectives for the position.

Attachment 3 - CPP Evacuation Coordinators (EC) Training Plan

Purpose

Emergency preparedness training is essential for every person in the Campus Community to be prepared for an emergency. Students see staff and faculty as the persons in charge of the classroom and they look to their instructors for direction during and after an emergency such as an "active shooter," fire, earthquake, or other emergency events. The staff and faculty of the University have a responsibility to ensure they are prepared in the event of an emergency to assist the students and their co-workers in an emergency. CPP Emergency Management has outlined a series, of course, that will instill the basic skills necessary to be prepared for any emergency that may occur. The Evacuation Coordinators (EC) play an essential part in the CPP Emergency Operations Plan, to assist with evacuations, promote emergency preparedness, and perform safety checks of the building they are assigned to.

In addition to the required training for University Staff and Faculty, as well as Quarterly Meetings, laid out in the in Attachment 4 CPP Staff and Faculty Emergency Preparedness Training Plan, a part of the CPP Campus Emergency Preparedness Multi-Year Training and Exercise Plan, Evacuation Coordinators are required to have the following additional training.

Required Presentations & Classes to Attend

Evacuation Coordinator Orientation Training

The EC orientation training covers: an overview of the CPP Emergency Management Program, EC responsibilities, EC role in each phase of the emergency management program, EC Equipment (Go Bag), Emergency Evacuation, EC training requirements, and future training.

Annual Evacuation Coordinator Training

The Emergency manager shall conduct training for the assigned ECs Annually, training may include: University Multi-Hazard Emergency Plan orientation, Building-specific planning, and preparedness, Building safety assessment, and Emergency procedures.

Attachment 4 – CPP Staff and Faculty Emergency Preparedness Training Plan

Purpose

Emergency preparedness training is essential for every person in the Campus Community to be prepared for an emergency. Students see staff and faculty as the persons in charge of the classroom and they look to their instructors for direction during and after an emergency such as an "active shooter," fire, earthquake, or other emergency events. The staff and faculty of the University, both on and offsite locations that have CPP staff and students, have a responsibility to ensure they are prepared in the event of an emergency to assist the students and their co-workers in an emergency. CPP Emergency Management has outlined a series, of course, that will instill the basic skills necessary to be prepared for any emergency that may occur.

The required training for University staff and faculty are laid out in Attachment 4 CPP Staff and Faculty Emergency Preparedness Training Plan, a part of the CPP Campus Emergency Preparedness Multi-Year Training and Exercise Plan.

Required Courses

CPP Emergency Management, EOC Operations, NIMS/SEMS, and ICS Fundamentals Training Course – All Staff

The purpose of this course is to provide the necessary Emergency Management, EOC Operations, NIMS/SEMS, and ICS fundamentals encompassing IS-100, IS-200, IS-700, and IS-800 courses in an adapted course best suited to meet the needs of the University. This course will equip participants with the knowledge necessary to make empowered decisions as members of the Campus Community.
