Legal Education Access Pipeline (LEAP) Fellowship

The LEAP fellowship is for Juniors, Seniors, or recent graduates who are first generation, students of color, students who identify as LGBTQ, and/or students who are or have been socio-economically disadvantaged, and who are committed to attending law school. The 9-month program consists of intensive mentoring at Loyola Law School (8 Saturday sessions from February – September 2025), skill building workshops, and a free LSAT preparation class. Application deadline is September 29, 2024, at NOON PST.

Application requirements:

- A completed application form, which includes four short essay questions (350 words or less per question)
- A resume
- An unofficial college transcript (minimum 3.0 GPA preferred)
- Two references (no letters required)

UVA Law's Roadmap Scholars Initiative

The Roadmap Scholars Initiative provides both academic support and practical experience to undergraduate students interested in attending law school by exposing them to different aspects of the legal profession. The program's goal is to prepare students to be competitive applicants to any of the nation's top law schools.

College students apply to the program during their sophomore year. A strong preference is given to applicants who are first-generation college students, students with limited financial resources, and/or students who are interested in pursuing a legal career but lack access to opportunities to learn about law school, the admissions process and the legal profession. Qualified applicants will be selected from a national pool. Ideal candidates will show a record of high academic achievement, convey a passion for being challenged as a learner and demonstrate a commitment to community service.

The Roadmap Scholars Initiative supports the scholars at every stage of the process, with summer stipends, paid travel expenses to and from Charlottesville, room and board for the summer program and paid LSAT course preparation. The program also has a mentorship program that connects the scholars to current UVA Law students.
