Summary of Past Research

- Business-friendly cities have fewer regulations (Douglas, 2017; Eagle, 2016).
- Business-friendly cities offer a one-stop shop: "what is needed to start a business" (NLC 100, 2023).
- Cities specializing in certain industries are more attractive to entrepreneurs (Walinder et al., 2023).
- Chambers that enhance members' credibility and network generate more member satisfaction (Farahi & Khadem, 2018).
- Chamber members are more likely to grow their businesses (Tiwasing & Sawang, 2021).

Data Collection

- Understand entrepreneur-friendly cities (past research).
- Develop questions relevant to business owners' operations and needs.
- Run the survey by the Chamber President to solicit feedback.
- Review survey flow and possible challenges.
- Pilot test survey to ensure validity.
- Input the survey in a Google form.
- Finalize survey.
- Distribute the survey.






Results (Respondents' business roles)

What products or services does your business/organization offer in Pomona? 32 responses



How many years has your organization been in business in Pomona? 32 responses




Where in Pomona is your business located? 32 responses


How many employees are currently employed in your business/organization? 32 responses


Only 9% operate as both brick-and-mortar and ecommerce.

What type of establishment do you operate?




Data Analysis (Reason for Pomona as Location)

What made you choose Pomona as your location?












Data Analysis (Use of Marketing Tools)


How do customers access your products/services?

Does your business/organization have a website and social media? 31 responses



Almost 30% do not use any technology!


What types of other technological resources do you use for your daily operations?




Does your organization have a business plan? 32 responses






Data Analysis (Annual Budget)




How do you set your business/organization apart from competitors? 32 responses


What are your biggest areas of concern regarding the operation of your business in Pomona?
